

Quality Management (QM) Recertification for Office of Developmental Programs' (ODP) QM Certificate Holders ODP Announcement 22-002

AUDIENCE:

ODP QM Certificate Holders who achieved certification/recertification during calendar year 2020.

PURPOSE:

To announce that those who achieved QM certification/recertification during calendar year 2020 are due for recertification by December 31, 2022.

DISCUSSION:

As part of ODP's QM Strategy, a QM Certification program was created in 2016 to build and sustain QM capacity throughout the service delivery system by enhancing the knowledge and skills of staff who function as leaders in quality management. Since that time, ODP has continuously improved the content and format based on feedback from attendees and offered multiple classes each year. As of December 2021, 897 individuals have become certified. Maintaining certification, through recertifying every two years, is highly recommended to keep QM skills honed and refreshed.

RECERTIFICATION:

✓ <u>WHO</u>: All staff certified/recertified during calendar year 2020 are required to recertify to retain their QM certification.

- ✓ <u>WHAT</u>: To recertify, staff must complete a review of 3 new training modules and a post-test, revised in June 2021, to become reacquainted with the following concepts and best practices:
 - Module 101: QM concepts, Centers for Medicare and Medicaid Services (CMS) quality assurances, ODP QM requirements, ODP QM Strategy, and QM best practices.
 - Module 102: Data usage in decision-making, data analysis/visualization, selecting improvement opportunities, and working with quality improvement (QI) teams.
 - Module 103: Using QM priorities in QM plans, developing performance measures/goals/objectives, putting QM plans into action, monitoring QM plans, and reporting progress in achieving objectives.

Recertification applicants have 2 attempts to achieve a passing score on the post-test of \geq 84%. There is a minimum waiting period of 24-hours between attempts, thus it is highly recommended that applicants do not wait until December 31st to take the test, as if they do, they will be limited to just one attempt to pass.

- ✓ <u>WHEN:</u> Those wishing to retain their QM certification must recertify by
 December 31, 2022.

Be sure to log in to MyODP first, to gain full functionality of the website to complete the recertification process.
