PURPOSE:

To inform all interested parties that the outage for important infrastructural changes to the Medication Administration Training Program will now be extended through Sunday, August 7, 2022. Trainers will be able to login and register to take the Train the Trainer course on August 8, 2022. Trainers will be able to administer new classes and students will be able to register in the system on September 6, 2022. If you attempt to conduct a class or complete any training on the system during this outage, your work will be lost.

** **Anyone who has not finished the course including the Face-to-Face and Lesson 12 as well as the exams by June 30, 2022 at 11:00 p.m. will lose all work that they have completed up to that point and will have to restart the course once the outage is over and the course re-opens on August 8, 2022. Incomplete coursework will not be migrated to the updated system.
