

# Open for Public Comment: Proposed Heightened Scrutiny Service Locations to be Submitted to CMS ODP Announcement 22-117

### AUDIENCE:

All Interested Parties

## **PURPOSE:**

To announce a 30-day public comment period on the Residential and Community Participation Support (CPS) service locations that the Office of Developmental Programs (ODP) proposes to submit to the Centers for Medicare and Medicaid Services (CMS) for Heightened Scrutiny. Public comment on each service location will be accepted until 11:59pm on December 19, 2022.

#### **DISCUSSION**:

On January 16, 2014, CMS published the Home and Community-Based Services (HCBS) Rule. The HCBS Rule created requirements for the qualities and characteristics of settings where waiver services are provided. CMS will presume that the following settings have the qualities of an institutional setting unless ODP sends information demonstrating that the setting has the qualities of a home and community-based setting:

• A setting that is located in a building that is also a publicly or privately operated facility that provides inpatient institutional treatment,

- A setting in a building on the grounds of, or immediately adjacent to, a public institution, or
- Any other setting that has the effect of isolating individuals receiving Medicaid HCBS from the broader community of individuals not receiving Medicaid HCBS.

# Public Comment:

Public comment is being sought on ODPs findings for each service location. ODP will review and consider all comments received by 11:59pm on December 19, 2022, in making a final determination as to whether each service location meets all regulatory and waiver requirements to overcome the presumption that the service location has

institutional characteristics. ODP encourages stakeholders to provide personal experiences with any of the service locations. This could include:

- Examples of how the service location supports opportunities for people to engage in community life.
- Examples of how people who receive services control their schedules and activities.
- Observations or experiences with how staff treat people who receive services.
- Observations or experiences regarding the ability of people receiving services to meet and speak with others in private (either in-person or via audio/video communication).
- Observations or experiences regarding people receiving services having a place to privately store their possessions or having a private space for personal care.
- Anything that ODP should consider about the service location that isn't included in the summary.
