DISCUSSION:

2024-2025 Peer Review Cycle

Temple University's 2024-2025 Peer Review cycle will begin in July 2024. Investigations performed by ODP AEs were selected through a customized sample report, and notifications will be sent, by Temple University, to inform AEs of the critical incident investigations selected for the Peer Review process. Incident number(s) selected for the Peer Review process will be communicated to the AEs under review. Once the peer reviews are completed, AEs will receive a copy of the results. All Certified Investigator Peer Review (CIPR) results will be shared with ODP.
