

MEDICATION ADMINISTRATION TRAINING COURSE

Remediation for Practicum Observers for Requalification

Requirement:

- One (1) Supervised medication observation per year for 3 years
- Two (2) Medication record reviews per year for 3 years

If the PO does not complete the yearly requirements as stated above, the PO cannot function as a PO until the remediation is completed. If PO has not completed the remediation within a year, then they will need to repeat the PO course.

*Note: The Annual Practicum anniversary date does not change. The current PO requirements tasks must be completed so that the PO is on time the next year.

Remediation for Practicum Observers for Requalification

YEARLY Requirements for Practicum Observers for 3-year Requalification

One (1) Supervised Medication Observation per year times 3 years = 3 TOTAL at the end of 3 years

Two (2) Medication Record reviews per year times 3 years = 6 TOTAL at the end of 3 years

1 supervised medication observation + 2 Medication record reviews = Requirements met → **NO REMEDIATION NEEDED**

If the PO does not complete the yearly requirements as stated above, the PO cannot function as a PO until the remediation is completed. If PO has not completed the remediation within a year, then they will need to repeat the PO course.

1 supervised medication observation + 1 medication record review only = Requirements NOT fully met →

REMEDATION NEEDED: PO Must

- Complete 2 additional record reviews for a total of 3 and
- Review "How to Conduct a Medication Record Review."

1 supervised medication observation + 0 medication record review = Requirements NOT fully met →

REMEDATION NEEDED: PO Must

- Complete 2 additional record reviews for a total of 4 and
- Review "How to Conduct a Medication Record Review."

0 supervised medication observation + 2 medication record reviews only = Requirements NOT fully met →

REMEDATION NEEDED: PO Must

- Complete 1 additional medication observation for a total of 2 and
- Review "How to Conduct a Medication Observation".

1 medication record review only + 0 supervised medication observations = Requirements NOT fully met →

REMEDATION NEEDED: PO Must

- Complete 2 additional medication observation for a total of 3 and
- Review "How to Conduct a Medication Observation".
- PO must complete 1 additional medication record reviews for a total of 2 and
- Review "How to Conduct a Medication Record Review".

0 supervised medication observation + 0 medication record reviews = NEITHER Requirements met →

REMEDATION NEEDED: PO Must

- Complete 2 additional medication observation for a total of 4 and
- Review "How to Conduct a Medication Observation".
- Complete 1 additional medication record reviews for a total of 2 and
- Review "How to Conduct a Medication Record Review".
