## Mobile Application Resources



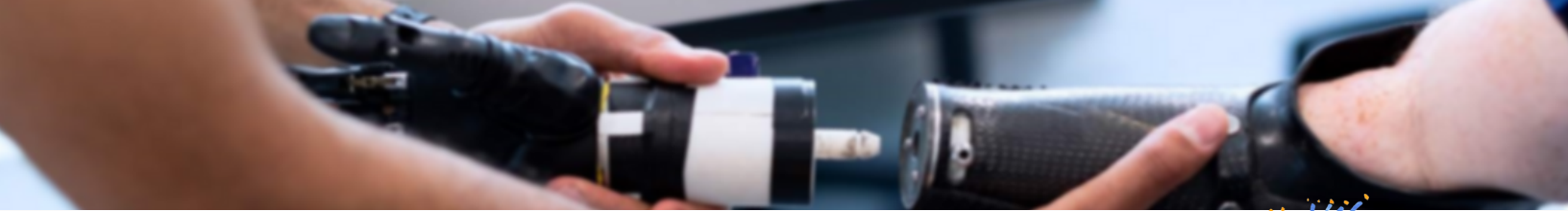

## Sensory-Friendly Holidays



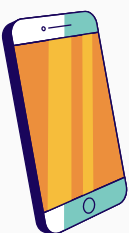

### TECH CORNER: Wegmans: Shopping Carts, Aira, & Hearing Loops

Attention Shoppers! Wegman's recently announced their newest addition of assistive technology within all of their stores! Their goal is to help make their stores accessible to all and to help "customers of all abilities enjoy their shopping experience."

Aside from standard **shopping carts**, Wegman's will now have 5 other types available to help those with specialized needs. Three carts to help carry children: baby car seats, child carts, and Caroline's cart; for children with special needs. The last two are to help those with physical disabilities: wheelchair carts and motorized carts.



Customers will now have free usage of the **Aira smartphone app**. This app helps connect visually impaired individuals with certified agents while shopping. The agents are able to see what the visually impaired person is seeing in real time to describe items/prices/sale and guide them in the right direction.

**Hearing loops**, also called an audio induction loop, will be available to those with hearing impairments at the service desk and registers. These hearing loops allow individuals to directly connect their hearing aids to any other technology they may be using such as self-checkout machines, for a more clear and effective sound.

## Personal Story

Like many other college graduates her age who are living back home, 25-year-old Alexa is ready to move out onto her own. While grateful for the support of her parents during this transition, Alexa has two exciting part-time jobs and she's ready for a change. And a change is imminent – Alexa and her parents recently purchased a ranch-style house in their community! With a move-in date scheduled for later this fall, Alexa and her family are busy planning the home modifications she'll need. In her parents' home, a SureHands ceiling lift helps Alexa get from bedroom to bathroom. The lift provides the support Alexa needs, and it's an easy and safe way for her to transfer. Alexa plans on getting an identical lift mounted in her new home, and she's making plans to widen the doorways, install a roll-in shower, and build a ramp so that she has a no-step entrance. All of these modifications will make it possible for Alexa to be more independent in her new home.

### What tasks are difficult for you?

- Will the use of AT help you complete these tasks more independently?
- Will you be able to use the AT in different places (work, home, social situations)?

### What have you tried before?

- What ways of doing things have you tried?
- What materials, equipment, or tools have you used in the past?

### How involved will you be in the process?

- Will you be part of the decision making to figure out what AT you should try?
- What do you hope the AT device will do for you?
- Will you have a chance to try it before buying it?

### How will you know if the AT device is a good fit for you?

- Will you be trained on the new AT device?
- Will you actually use it?
- Will it help you meet your goals?

## Charting the LifeCourse

"Charting the LifeCourse" is a comprehensive framework that helps individuals and families plan and achieve their life goals by providing a person-centered approach to planning. It offers a range of tools and principles to support individuals with disabilities in achieving their desired outcomes and improving their overall quality of life.

One of the person-centered tools we would like to highlight is the Integrated Support Star. The Integrated Support Star helps organize and generate ideas in the following areas: Personal Strengths and Assets, Relationships, Eligibility-Specific, Community-Based and Technology. The support star can be used for planning, problem-solving, and exploring.
